

## OFFICIAL RULES FOR THE “2023 DAYTONA 500® Fancam Sweepstakes”

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**SWEEPSTAKES PERIOD:** The 2023 DAYTONA 500® Fancam Sweepstakes (“Sweepstakes”) begins on February 20, 2023 at 12:01 a.m. Eastern Standard Time (“EST”) and ends on March 20, 2023 at 11:59 p.m. EST (the “Sweepstakes Period”).

**HOW TO ENTER:** During the Sweepstakes Period, there is one (1) way to enter: **Online:** Enter the Sweepstakes by visiting <https://nascar.fancam.com> and click the sweepstakes banner. Follow the instructions to complete the registration form by entering your name, email, phone and address information. Entries generated by script, macro or other automated or mechanical means or by any means which subvert the entry process are void. Limit one (1) entry per person, per email address. Entries received from any person in excess of the limitation will be void. All entries become the sole property of the Administrator and will not be returned. Released Parties (as defined below) are not responsible for lost, late, incomplete, delayed, or misdirected entries. Incomplete or fraudulent entries will be void.

**ELIGIBILITY:** Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia who are of the age of majority or older in the applicable jurisdiction.
